### **6. Discussion Items**

#### **6.A. Bill Hobbs Award and MLK Human Rights Contest**

Staff Kaempfer shared the nominees for the Bill Hobbs Award. Commissioners discussed who we be awarded and decided that for 2025 two nominees would be given the award. Staff Kaempfer noted that he will take care notifying the awardees, contacting the Communications Department, and adding information to the Council's agenda for the December 16<sup>th</sup> meeting.

Commissioner Murphy shared about the upcoming MLK Human Rights Contest along with the efforts already in place to get students excited about participating. Staff Kaempfer shared that no submissions have come in yet and that the deadline can be adjusted if needed.

#### **6.B Work Plan Review**

Commissioner Paradise shared about the current status of the work plan and what to expect for the next year.

Staff Kaempfer noted that in the previous meeting the Commission wanted to change the advertising of the Commission's event to only use the term "DEIC Event". Commissioner agreed that for future events it will either be "DEIC Event."

Commissioner Paradise noted that things will change in the work plan as there will be input gathered from the upcoming DEIC event in December.

The Commission also discussed topics for event, which will be taking place in Q1 of 2026 and to make sure that something is selected although input is still needed from community. Commissioner Paradise and Briggs agreed to do an event in March about housing in Golden Valley. Commissioner Alberth agreed to do an event in June about ageism.

## **7. Subcommittee Updates**

### **7.A. City Systems**

Commissioner Alberth shared that the subcommittee provided feedback about the City's AI Policy and met to discuss various projects that the subcommittee is working on. Commissioner Alberth noted that they are developing a memo to provide back to the consultants and Community Development regarding missing middle housing study and approach.

### **7.B. Communication and Networking**

Commissioner Murphy reminded the Commission that they are going to make the subcommittee more robust over the next year and having a stronger focus on the networking aspect.

Commissioner Murphy noted that the DEIC will be planning an inter-city event that gathers DEI commissions and human rights commissions to plan together, share resources, and support one another.

Commissioner Paradise shared about her approach to communication, which includes using a list of names and contact across the west Metro area.
