



JUNIOR RECREATION VOLUNTEER PROGRAM

Golden Valley's Junior Recreation Volunteer Program provides youth ages 13–15 with a volunteer opportunity to gain leadership experience and valuable work skills by assisting recreation staff with playground programs.

This volunteer program requires candidates to submit an application and participate in an interview. Candidates selected for the program will need to pass a background check and fulfill two assigned shifts per week (for six weeks).

Candidates chosen for the program will need to complete a background check.

Junior Recreation Volunteer Duties

- Work as a member of a leadership team that provides outdoor fun for youth programs
- Lead program participants in organized games and activities
- Assist staff with supervision of participants and setting up program activities

Applications can be turned in starting March 1, 2026. All applications will be reviewed after the deadline.

This authorization expires one year from the date of my signature.

I hereby irrevocably waive any and all claims against the City or any of its officials, employees, or agents for any bodily injury (including death), loss, or property damage incurred by me as a result of my participation in the Program.
